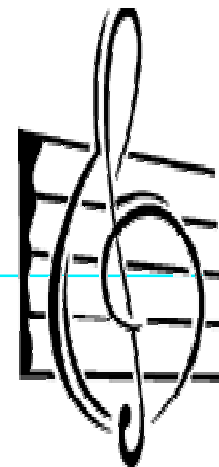

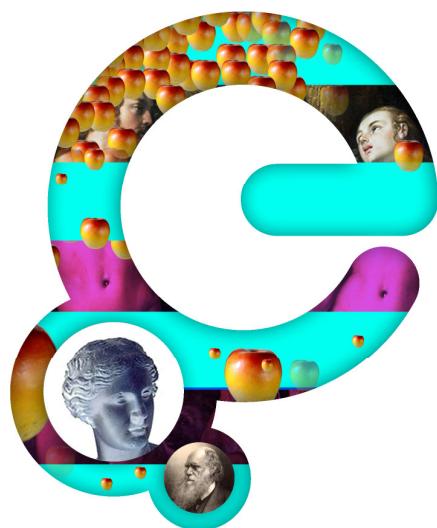

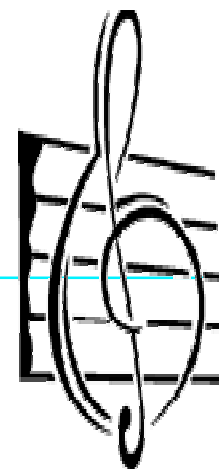
[Europeana Schematic Elements 3.2](#) – latest Europeana dataset
